


In this report

Pollicy's approach to data and technology is rooted in promoting responsible data use, appropriate data governance practices, and policies that support an enabling data ecosystem. As part of this approach, Pollicy is creating a pan-African approach to data governance by bringing together thinkers, influencers, and policymakers to exchange ideas and influence laws, policies, regulatory authorities, and decision-making frameworks. Pollicy also hosts various data events, such as DataFest Africa, which brings together data scientists, technologists, designers, government, civil society, business, and marketing to connect and explore opportunities for collaboration. Additionally, Pollicy provides data training through various programs that build data literacy among civil society and government partners and promote appropriate research methodologies, data collection, analysis, visualization, dissemination, and storage. Pollicy also engages in feminist technology movement building by promoting the use of technology as a tool for empowerment and amplifying African women's voices in emerging technologies to reduce the gender gap in employment and influence in software, technology, and digital tools. Lastly, Pollicy cultivates a vibrant digital rights community through the Digital Human Rights Lab, studies the intersection of human rights, media, and the digital landscape, and engages in policy advocacy efforts aimed at highlighting the

Description of research methodologies and approaches

Pollicy's research approach is grounded in feminist methodologies, which prioritize equity, inclusivity, and empowerment. Through mixed-methods research, we explore the role of data in society today, investigating emerging issues within the data ecosystem such as accessibility, affordability, participation, engagement, expression, and innovation. By taking an intersectional lens, we ensure that our research reflects the diversity of experiences and perspectives within our communities. Our research aims to inform policy and practice as well as promote responsible data use and governance.

Overview of training and events

At Pollicy, we believe that building data literacy is crucial to promoting responsible data use. That's why we offer a range of hands-on, participatory training courses to our civil society and government partners. Our training covers ethical practices, research methodologies, data collection, cleaning, analysis, visualisation, dissemination, and appropriate storage and retrieval. In addition, we also facilitate connections between our partners and host a variety of events to expand the discourse on data use. Our flagship event, DataFest Africa, is held annually in Kampala, Uganda. We also organize various workshops and webinars for the broader community, ensuring that everyone has access to the knowledge and tools needed to make informed decisions about data.

Overview of development and media efforts

At Pollicy, we believe in the power of data to drive decision-making and development. To this end, we use openly available datasets to build data products that make data sharing and use easier for all. We also recognize the importance of creative approaches in tackling the pressing issues of our time. Our media efforts are focused on making our outputs more accessible to wider audiences. We work hard to convert our research into easily digestible formats such as infographics, podcasts, games, short films, murals, and even dances. We cover themes such as machine learning, disinformation, and digital self-care, among others. Our approach ensures that the messages we aim to convey reach as many people as possible.






What did you find most rewarding in 2022?


Strengthening the data ecosystem across Africa

Pollicy is committed to promoting a responsible and enabling data ecosystem across Africa. We are creating a pan-African approach to data governance by bringing together thinkers, influencers, and policymakers to exchange ideas, and by engaging in advocacy efforts aimed at influencing laws, policies, regulatory authorities, and decision-making frameworks. As part of this approach, we have established partnerships with organizations such as;

The Africa Data Governance Hub

Implementing together with NIYEL, Pollicy is building a Data Governance Hub. The hub is the most diverse, transformative and inclusive knowledge hub in Africa with a collation of data governance resources and actors. It exists to promote greater collaboration within the data governance sector in Africa by fostering knowledge sharing, connections and collaborations on data governance issues across the continent. Our community represents activists, policy makers, researchers, government Institutions, advocacy organisations, philanthropy organisations, Ph.D. students, young students, grassroots organisations, feminist organisations and people new to the sector among others, who are committed to a shared set of goals, working towards advancing data governance in Africa.





Developing AI policy frameworks with IDRC

Pollicy together with The International Development Research Centre started developing AI Policy Frameworks. These will support in contributing to conversations around AI governance on the African continent. The result to be launched in 2023, draws from a variety of non-exhaustive examples, highlighting areas where a new approach to AI is critically needed.

At DataFest Africa, we discussed the latest developments in the world of big data, little data, and everything in between, and we were proud to work with partners from Uganda, including the government, as well as forge new partnerships in Tanzania and Nigeria.





The 2022 DataFest Africa Hackathon

In addition to the workshops and discussions, DataFest Africa also featured a hackathon organised in partnership with Sunbird AI and Zindi Africa. The theme of the hackathon was "Noise Pollution Challenges in Africa," particularly in large cities. This offered participants an opportunity to work on real-world challenges and develop impactful solutions to the communities.

Spotlight:

Enduring Blindspots & Infinite Opportunities: Digital Creative Industries in Uganda

n 2022, we launched our paper; Enduring Blindspots & Infinite Opportunities: Digital Creative Industries in Uganda. The research led by Zulfa Bobina our Data and Digital Rights Researcher, aims to understand the experiences of digital creatives in Kampala, Uganda, through a gendered lens. There is a large gap in the availability of data and knowledge on the digital creative industry in Uganda and this paper aims to address some of these blindspots. To understand these experiences, this body of work explores a number of sector wide concerns through exploratory qualitative research methodologies around issues of access and use of digital technologies by digital creatives, the role of emerging technologies on the sector and finally, the policy ecosystem governing the creative industry in Uganda. The paper also draws from existing literature on the traditional creative industries in Uganda given the limited scholarship on the digital creative industries in the country.




